Sub: Regarding Centralized Online Admissions for UG Courses for the Session 2023-24.

Kindly refer to the subject cited above.

In continuation of this office letter no. DHE-170005/5/2023-Deputy Director-NPE dated 08.06.2023 in which it is mentioned that for *for KUK affiliated colleges admissions will be done by the Directorate of Higher Education inline with NEP alongside the admissions of affiliating colleges of other State Universities on old pattern by making necessary changes in the centralized portal*". So in view of this, following instructions may be followed:

- The basis of admission in Multidisciplinary programme in NEP (Bachelor of Arts, Bachelor of Physical Sciences & Bachelor of Life Sciences) shall be only major subjects/courses (Core Courses/Discipline Specific Course) and minor subject/course (Minor/Vocational Course). The same shall be allocated through Centralized online admission portal inline with NEP for KUK affiliated colleges and other subjects/courses viz. MDC, VAC, AEC, SEC etc shall be allocated at the college level. However, in case of Interdisciplinary programmes and Honours programme, the courses/subjects inline with NEP shall be allocated by the colleges only. The centralized online admission portal will work on this pattern.
- Colleges may offer the major and minor subjects/courses inline with NEP as per existing infrastructure, faculty, students and timetable spread etc.
- The seats of all courses/programmes running under the umbrella term of Bachelor of Physical Sciences (as per NEP) be cumulated/merged for effective implementation of National Education Policy. The same scenario shall apply to Bachelor of Life Science Programme under NEP. In these cases, Principals of the Colleges are directed to distribute cumulative/merged seats during subject grouping/allocation on admission portal after considering existing infrastructure and faculty in order to effectively implement NEP. In case of Bachelor of Arts, the Principals shall distribute the allocated seats among the sanctioned subjects as per the existing infrastructure and the faculty.
- The Colleges *(wherever NEP is applicable)* having Computer Science and/or Geography as subjects, the Principals can have one of the options to allocate these subjects/courses either to Bachelor of Arts students or Bachelor of Physical Sciences or Bachelor of Life Sciences students in order to effectively implement National Education Policy subject to fulfilment of norms of affiliating university.
- Weightage criteria for admissions to UG programmes will be same as adopted by State Government.
- University fee/funds shall remain same as per existing system.
- Eligibility for various Programmes/Courses shall be as per affiliating university norms.
 - The staff members put on admission duty by the Principals during summer vacations notified by their affiliating universities may be granted Earned/Compensatory Leaves as per State Govt./University norms and as per previous year practices.
